BIS announces relaxation for MSMEs

Bureau of Indian Standards (BIS) in view of the extra ordinary situation in the country due to lockdown and to lessen the financial burden for MSME manufacturers holding or seeking BIS licence in the country, has announced the following relaxations in fee for both the grant of licence and renewal of a licence under product certification (mark) scheme as per BIS (Conformity Assessment) Regulations, 2018 to MSME units during 2020-21:

i) An additional rebate of 20% in minimum marking fee, ii) Option to pay marking fee in two instalments of 6 months without additional cost, iii) Rebate of 20% on inspection fee for all new applications and special visits, iv) Inclusion request fee charges of ☐ 5000/- irrespective of number of varieties, v) Renewal of licence after validity date without charging late feeupto 30th Sept. 2020, vi) Time limit for deferred licence has been extended beyond 90 days upto 30th Sept 2020, vii) Waiver of inspection fee in case of re-visits to the factory arising out of reasons linked to lockdown such as expiry of shelf life of samples etc., Additionally, for management system certification scheme, application fee of \square 1000/- to be charged from MSME manufacturers instead of \square 7000/-. These relaxations will address situations of immediate liquidity crunch faced by MSME units to continue manufacturing quality certified goods.

3rd Death of COVID-19 in BSF

Constable Vinod Kumar Prasad breathed his last on 9th June 2020 in AIIMS, New Delhi, taking the total number of deaths in the Border Security Force (BSF) to three due to COVID-19. Prasad was deployed for Law and Order duty with Delhi police, and admitted to AIIMS New Delhi on 5th June with complaints of weakness and cough. His samples taken for COVID-19 on 6th June were negative but his condition deteriorated on 8th June and breathed his last on 9th June in ICU of AIIMS, New Delhi. His COVID-19 sample of 8th June 2020 was found positive. Constable Vinod is survived by his parents, wife and son. Director General and all ranks of BSF are grief stricken at his untimely demise and offer condolences to his family members. Entire Prahari Pariwar stands united with the bereaved family in this trying times. Currently, in BSF there are 100 Active patients, 435 have recovered and three have died.
